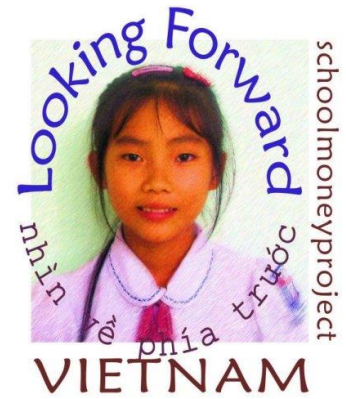


LOOKING FORWARD FOUNDATION

SCHOOL MONEY PROJECT



I. PURPOSE

- To help children from poor families but studious, have strong will to overcome their difficulties, to realize their legitimate dreams, to continue their study so they may help their family and contribute their ability for the country in the future.
- Fund from donors in the Netherlands, voluntarily contribute and donate to one or more students from grade 1 to grade 12. This assistance is completely non-profit and non-political purposes, non-religious and non-gender preference.

II. OBJECT:

Children are studying at primary schools, secondary schools, high schools in Khanh Hoa Province.

III. CONDITIONS AND CRITERIA FOR CONSIDERATION OF FINANCING

A . Students Grants must meet the following demands:

- Orphans, or parents with serious sickness, disability labor, or families in difficult circumstances.
- Disabled children, weak health but strong will .
- Not receive donations in cash or scholarship, the regular funding of organizations or individuals.
- Having efforts in learning, good ethics.

B. The level of funding

- Children at primary schools are supported 250.000 VND / month and receive 1.000.000 VND every 4 months in January, May and September.
- Children at secondary schools and high schools are sponsored 350.000 VND monthly.
- Children live far from Nha Trang and Dien Khanh can be received every 4 months in January, May and September.

- Scholarships will be distributed directly to students or through teachers in charge of schools.

IV. PROVISIONS OF CONTINUING SCHOLARSHIP AND TERMINATION OF SPONSORSHIP

A. Conditions of continuing granting scholarships :

- Students achieve good ratings upwards (children at primary school /secondary school), ranked above average or higher (high school), good behaviour.
- At the end of each school year, the schools send the results of study of the children to the manager of Looking Forward in Vietnam to report to the sponsors in the Netherlands.
- Based on the study results of children, Looking Forward review if the children can be provided scholarships or terminate funding.

B. The case of termination of sponsorship:

- Students with disciplinary school or quit school.
- Students who have completed Grade 12.
- Students move to other provinces.
- For special circumstances, Looking Forward will consider the specific funds and have separated decisions.

V. PROCEDURE APPLIED FOR SCHOLARSHIP

A. At school: The form teachers introduce the students who meets the demands and these students must be approved by the principals of their schools then send the list to the LF manager to apply for a scholarship.

B. In the locality: The chairman of Study Promotion Society of the local area where children are living suggests the children who meets the demands and sends the list to the LF manager to apply for a scholarship.

After the board of LF approve, the list of students awarded scholarships will be notified to students at school or to the Study Promotion Society of the commune or ward where children is residing and to individual student.
